## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. **Inhalation:** If dusts have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists for more than about 30 minutes, seek medical advice

## Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

Only small quantities of decomposition products are expected from this product at temperatures normally achieved in a fire. This will only occur after heating to dryness.

Fire decomposition products from this product are likely to be irritating if inhaled.

## Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this MSDS and the label, instructions on the label prevail. Dispose of only in accord with all regulations.

## Section 7 - Handling and Storage

**Storage:** Store in a cool, dry place away from children and animals or foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Keep from extreme heat and open flames, and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10.

*Exposure limits have not been set for any ingredients in product. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.
