Clay and Loam Profile	200-350kg per hectare	Apply as required to improve soil texture and enhance microbial activity.	
Topdressing Sand	1-3% of total Mix	Incorporate as uniformly into the sand as possible.	
Potting Mix	1-5% of total Mix	Incorporate into the mix uniformly, prior to potting.	
Bedding Mix	500g-1kg / 100m ²	Turn into beds at creation and rebuild.
