SITUATION	RATE	CRITICAL COMMENTS
Bowling Greens	1600ml in 1600 litres of water	Apply to standard bowling green.
Golf Greens	100ml in 100 litres of water/100m ²	Apply at 3-4 weekly intervals during the growing season.
Sugar Cane	100ml in 100 litres of water	Dip sett in solution immediately after cutting. Shake off excess solution. Replenish made up solution regularly.
Cuttings & Pippings	10ml in 10 litres of water	Dip cuttings or pippings in solution before planting.
Playing Fields & Ovals	10 litres in 1000 litres of water per hectare	Apply at 3-4 weekly intervals during the growing season.
