Section 4 - First Aid Measures

Section 6 - Accidental Release Measures

Spillage: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material.
