Section 4 - First Aid Measures

Exposure limits have not been set by SWA for any other ingredients in product. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL.
