## STORAGE AND DISPOSAL:

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. Refillable containers: Empty contents fully into application equipment. Close all valves and return to designated collection point for refill or storage.

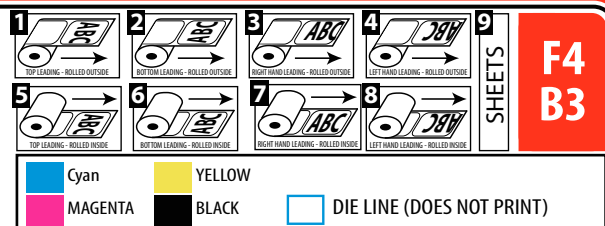
